We also sell a wide range of accessories and related products. We are certified in Quality ISO 9001 and Environment ISO 14001. Likewise, the Management of MANUFACTURAS GRE, S.A. is committed to implementing and maintaining the chain of custody requirements in accordance with the PEFC standard (PEFC/14-38-00166) in force at all times.

With the aim of achieving the highest level of leadership in our market segment while promoting occupational risk prevention and environmental protection, the management of MANUFACTURAS GRE, S.A. is committed to developing and maintaining at all times an 'Integrated Management System' governed by the following principles:

1. To satisfy all the requirements of our current and future customers and analyse all information provided by them as a fundamental basis for the improvement process.
2. Strengthen stable cooperative relationships with our suppliers through agreed quality agreements in order to minimise both internal and external rejections.
3. Obtain certification for our swimming pools in accordance with European standards.
4. Promote sustainable development and actively contribute to protecting the environment and its continuous improvement, based on compliance with all legal and other requirements to which we subscribe.
5. Prevent environmental pollution by regularly reviewing the environmental aspects associated with existing or future processes, products, and activities.

We are aware that in order to properly develop our Integrated Management System, we must take responsibility for achieving objectives that are established and verified at least once a year by management and focused on fulfilling our commitment to continuous improvement in the areas of quality, safety and the environment.

The necessary human and material resources will be deployed to achieve these objectives. Our management is based on the active participation of all employees, whose information/opinions are considered essential for improving working conditions at MANUFACTURAS GRE, S.A.
